## **REGULATIONS AND REQUIRMENTS**

Team Composition & Eligibility

Playing an ineligible player disqualifies your team from the tournament and is banned from participating in any Offense-Defense events.

All teams must have a birth certificate for each player, Current Photo taken during this calendar year, a current sports physical and a roster available at the field each day. A Weigh-In will take place before the first game is played.

To accommodate any necessary re-verifications, allow for adequate warm-up and ensure that the games start in a timely manner, all teams must check-in at the appropriate field two (2) hours before their first game, and one (1) hour before each additional game.

## **PROTESTS**

If a protest arises concerning a player's eligibility, the representative for the protesting team must pay a protest fee of \$100 to begin the protest. The representative of the team being protested against must then present the ODFL official with the birth certificate for verification. Verification should be presented immediately. Failure to furnish the birth certificate during the protest will result in a forfeit (non-refundable).

## **TOURNAMENT ENTRY**

- All teams Rosters must be in by November 1st. The weight information will be added at the weigh-in. Players may not change teams once the roster has been submitted.
- Only players' names that appear on the official roster may compete in the tournament. However, all players from the official roster are not required to compete.
- All teams are required to bring two (2) jerseys. One dark for the home team and one white for the visitor designation.
- Players shall not have the same jersey number on a team.
- Jersey number changes must be reported to the tournament director.
- No new player can be added to the roster after Nov 15<sup>th</sup>.
- Each team must pay a non-refundable registration fee of \$300. Checks can be made payable to Offense-Defense Sports.
